Computer Damage/Loss Cooperative Program Application Form
2018-19 School Year

Please read this entire document to determine if this program is needed for you and your student's protection against damage and loss of the loaned computer equipment in your care. Participation in this program is VOLUNTARY. This form must be completed and marked YES or NO before the computer will be loaned to the student.

COVERAGE AND BENEFIT: This program covers the computer equipment loaned to the student against all accidental damage. Total value will be determined by the District at the time of loss or damage. Computers that need repair due to accidental damage the participants of this program will be required to pay for 20% of the repair cost. To review repair costs as part of this program please visit the Millard Public Schools One-to-One website at <http://one-to-one.mpsomaha.org/forms-documents>. Failure to use the school provided computer carrying case/bag during transport of their computer may void this coverage. **Damage due to gross negligence or intentional acts will not be covered under the cooperative loss program.**

The following types of claims are limited to ONE per device per year: Computer replacement due to loss, theft, or excessive damage; damaged/cracked computer screen.

The following claim type(s) are not covered by this program: Computer carrying case/bag & lost/stolen AC Adaptor.

In no case shall the actual computer value be greater than \$350.00. In the case of a total loss, the student will be responsible for no more than 20% (\$70.00) for a replacement computer. **In the event of the computer being reported LOST or STOLEN Millard Public Schools will require the student/parent to file a police report and submit a copy to the District.**

EFFECTIVE AND EXPIRATION DATES: This coverage is effective from the first day premium payment is received by the school through August 1, 2019 or the date at which the computer is returned in good working order to the school.

PREMIUM: The total premium cost is \$20.00 per school year. In the event of student withdrawal from the District prior to the end of cooperative agreement, premium costs will not be refunded.

PROGRAM DESCRIPTION: The Millard Public School District offers your student the opportunity to participate in this Computer Damage/Loss Cooperative Program. This program is designed to protect students and families in the event the loaned computer equipment is lost, stolen, or damaged. **Coverage is totally voluntary.** A separate application will be needed every school year.

This form must be completed and returned to your child's school before computer equipment will be loaned to your student. One form per student is required.
